

ISO 44001 Internal Auditing

ISO 44001 Internal Auditing is a two day face-to-face course. The course is delivered by Institute for Collaborative Working Australia Directors Brett Ackroyd and Josh Choong. The course aims to equip delegates with an understanding of how to audit a Collaborative Business Relationship Management System. The course focuses on use of appropriate approaches to ISO 44001 auditing, ensuring realisation of benefits, and identifying enhanced value from the relationships.

ISO 44001 Internal Audits are an essential and important part of maintaining and improving an effective Collaborative Business Relationship Management System. They enhance value and maintain the ongoing ability to collaborate. Internal audits are a key tool for: facilitating continual improvement, identifying good practice, maintaining compliance, providing confidence to stakeholders, providing vital information for management reviews, identifying early warning signs of system failure, and reducing business risk. Internal Audits are a critical step to ensure management systems are compliant for organisations intending to achieve certification to ISO 44001 with BSI.

The **ISO 44001 Internal Auditing** course is recommended for staff with in-house auditing responsibilities for an organisation, and is also suitable for those who provide independent auditing services to external parties. Auditing skills are assumed as pre-course knowledge. The course focus is on understanding ISO 44001 from an auditing perspective.

Course content includes:

- Background to ISO 44001 and Collaborative Working as a business discipline,
- The structure of ISO 44001 and its requirements, including the Collaborative Business Relationship Management System and Collaborative Business Relationship Eight Stage Lifecycle,
- Where to find evidence when conducting audits to ISO 44001,
- Approaches to audit planning and identifying the most appropriate approach for the organisation,
- Creating effective audit plans and building audit checklists, and
- The role of the auditor within ISO 44001.

ISO 44001 Internal Auditing is based on a course developed as a collaboration between Institute for Collaborative Working (ICW) UK and BSI.
